## 1. Preliminary information

This Call for Applications is addressed to non-EU applicants who are not residing in Italy and are applying for a Visa at the Italian Embassy or Consulate, have a study qualification obtained abroad, and intend to enrol in the Master's Degree Programme in LANGUAGES FOR COMMUNICATION IN INTERNATIONAL ENTERPRISES AND ORGANISATIONS (LACOM) for the academic year 2025/2026. Places available: 20

The LACOM course is open for the enrolment of non-EU candidates:

- 1. with an appropriate Bachelor's Degree
- 2. who meet the requirements listed in section 2 "Requirements" of this call for applications
- 3. who have adequate personal abilities and skills assessed under the procedures mentioned in section "3. Assessment of academic background" of this call for applications.

Students are not required to pass an Italian language test as the course is taught entirely in English.

All applicants must submit their APPLICATION FOR ASSESSMENT **no later than 15 April 2025** (CET), indicating the two foreign languages they want to study (from a choice of English, French, German, and Spanish). They will be assessed on the basis of **the documents provided testifying their academic background**. If necessary, they will also have an interview.

Italian and foreign applicants with an Italian academic qualification, as well as EU-applicants (regardless of their residence) and Non-EU applicants regularly residing in Italy and in possession of a degree awarded in a foreign country **shall not apply to this call**, but they shall apply and follow the procedures described in the call for applications specifically reserved for them which will be published approximately by April 2024.

## 2. Requirements

Applicants are required:

- a) to have a university qualification (Bachelor degree) in the following areas: Modern language studies, Economics and marketing, Communication studies, International relations and political studies, Business administration, Tourism management
- b) to have adequate language skills in the two languages to be studied (chosen from English, French, German and Spanish)
- c) to have at least a B2 level of language competence in English regardless of the two chosen languages, as the course is taught entirely in English
- d) to have an academic background and training/professional experience pertinent to this specific type of course.

## 3. Assessment of Academic Background

Applicants' competencies and skills will be assessed on the basis of their academic background as described in the documents attached to the application and, if necessary, with an interview via Skype, Meet, Teams, Zoom.

Applicants' academic background will be assessed on the basis of their knowledge of foreign languages (English, French, German or Spanish) with a specific focus on competences concerning syntactic, lexical, textual and pragmatic features of the language(s) studied, as well as on the different registers of spoken and written language.

As the course is taught entirely in English, the applicants must demonstrate at least a B2 level (Common European Framework of Reference) in English by means of **international language certificates** or, alternatively, **declarations by the home university** (Language Centre or Department) stating that the applicant has reached the required level. These declarations must be drafted on official University letterhead and written in English.

# 4. Submitting an online application for evaluation

To submit their application, students must:

- register on the website <a href="www.esse3.unimore.it">www.esse3.unimore.it</a> to get the username and password required for access to the Restricted Area. Please check that the e-mail address provided is correct in order to receive any future communications.

- after logging in, choose *Registered/Student Area* from the menu tab and enter the reserved area, then choose "**Application for evaluation**"
- after choosing the LACOM Programme, answer 'Yes' to question: "Are you an International student with a foreign degree, residing abroad, applying for a visa through the Italian Embassy/Consulate?" then fill in the online application and attach the documents listed below:
  - degree certification containing the following information: type of university degree, when and where
    it was awarded (in which university), date and final mark, list of examinations taken with relevant
    grades. Please also attach a copy of the university diploma along with all documents deemed useful
    to prove knowledge of foreign languages (English, French, German and Spanish). Documents are
    accepted in English, French, German and Spanish; for other languages, a translation of an official
    translator is required
  - 2. **copy of international language certificates stating a B2 level or higher** in the first and second language chosen for the study programme respectively (English, French, German and Spanish). Regardless of the two chosen languages, applicants must attach a certificate stating at least a B2 level in English.

#### Alternatively

**statements issued by the home University** (University Language Centre or Department) certifying that the applicant has achieved the above-mentioned language levels

- 3. **personal statement** written in English, in which the applicant explains why s/he wishes to apply for this course
- 4. **curriculum vitae**, written in English based on the Europass model
- 5. **reference letter** written by a university professor who is asked to comment on the applicant's academic suitability for the chosen course
- 6. **any other qualifications** that applicants want to be considered for admission purposes (e.g. internships, university master programmes, further education, etc.).

**IMPORTANT**: the application is completed and correctly submitted only **after saving the data and answering YES to the question** "Do you want to submit your application now?".

Should you need to open the application again to change any data or add documents before the assessment begins and within the deadline of **15 April 2025**, send an e-mail to the Registrar's Office segrstud.studilinguistici.culturali@unimore.it

## 5. Assessment Results

The assessment results will be made available to applicants on https://www.unimore.it/en/ateneo/bandiegare/call-application-and-results-languages-communication-international-enterprises and also sent via e-mail to the address indicated at the time of registration.

The above-mentioned page will show one of the following results by 6 May 2025:

- PASS: the applicant's academic background is appropriate. S/he can enrol.

- ADDITIONAL REQUIREMENTS: the applicant's language skills in the chosen language(s) cannot be
  assessed from the submitted documents, or no international language certificates or declarations
  issued by the home university have been provided. Therefore, the Examination board will interview
  the applicant on an agreed date via Skype, Meet, Teams, Zoom.
- FAIL: the applicant does not meet the requirements and the Examination board explains why the competencies and skills have been considered unsuitable; as a consequence, enrolment is not allowed.
- INCOMPLETE APPLICATION: no assessment can be made because the applicant has not uploaded the required documents (degree certification and list of examinations taken with relevant grades; personal statement; curriculum vitae; reference letter). In this case, the online application is automatically re-opened so that the applicant can upload the missing documents and finally close the application for a new assessment.

If one of the messages appears:

- NOT FINAL APPLICATION: the applicant has not submitted the application by clicking on "Do you want to submit your application now?" and therefore the Board cannot assess it.
- FOR ASSESSMENT: the application has been correctly submitted by the applicant, but the Examination board has not yet assessed the submitted application

## 6. Enrolment

## 6.1 Pre-enrolment on Universitaly for the purpose of obtaining a student visa

As indicated in the Italian ministerial circular for access to study programmes, which is published every year on the website <a href="www.studiare-in-italia.it/studentistranieri/">www.studiare-in-italia.it/studentistranieri/</a>, Non-EU applicants residing abroad must request a visa on the UNIVERSITALY website by clicking on the link <a href="https://universitaly-private.cineca.it/index.php/login">https://universitaly-private.cineca.it/index.php/login</a>

Their application is automatically sent to UNIMORE for validation. UNIMORE will notify the Italian Consular Authority in the event of admission to the study programme.

Applicants have to upload the following documents on the Universitaly website:

- their passport
- their photo (passport size)

Any further documents relating to their academic qualification may also be attached, including:

- declaration of value, issued by the Italian Embassy/Consulate in the country to which the school issuing the qualification belongs or, alternatively
- **statements issued by ENIC-NARIC centres** such as the certificates released by CIMEA, as described in paragraph 6.2 Enrolment.

Please contact the reference Embassy/Consulate as soon as possible to check the requirements and the documents needed for the visa to be issued.

#### **6.2 Enrolment**

To enrol in the LACOM Programme applicants must:

- have completed the pre-enrolment procedure on the Universitaly website
- obtain a student visa for Italy in time for the enrolment.

Enrolment deadline: 22 December 2025

The following documents must be submitted for enrolment:

- 1. Bachelor degree diploma, translated and legalised by the Italian Embassy/Consulate
- DECLARATION OF VALUE of the university degree, issued by the Italian Embassy/Consulate in the country to which the school issuing the qualification belongs, or alternatively, a declaration issued by ENIC-NARIC centres
  - or, alternatively the following documents issued by CIMEA <a href="https://www.cimea.it/">https://www.cimea.it/</a>:
    a) STATEMENT OF CORRESPONDENCE downloaded directly by the candidate on the "Ardi" platform at <a href="https://ardi.cimea.it/">https://ardi.cimea.it/</a>it (for Lisbon Convention countries). If the country in which the degree was obtained is not among those listed on the "Ardi" platform CERTIFICATE OF COMPARABILITY to be requested from CIMEA by registering on the site <a href="https://cimea.diplo-me.eu">https://cimea.diplo-me.eu</a>.
    Attention: CIMEA does not issue the Certificate of Comparability if the Certificate of Correspondence is available.

- 3. Degree certification, issued by the University awarding the degree
- 4. Receipt issued by the post office in Italy, certifying the filing of the application for a residence permit
- 5. Passport
- 6. Passport photo

After verifying the correctness and completeness of the documents submitted by the student, the forms for the payment of tuition fees (academic year 2025-2026) will be made available on the applicant's personal page on Esse3 and the Registrar's Office will confirm the enrolment once the first instalment has been paid.

#### **IMPORTANT**

Please note that the PAYMENT DATE indicated on the electronic payment receipt applies.

Payments reporting a date later than 22 December 2025 on the receipt will not be deemed valid for enrolment purposes.

PLEASE NOTE According to AgID (Digital Italy Agency), the payment may be made by the payment service provider on the day following the payer's request. This would preclude enrolment.

## 7. Student services

## 8. Tuition Fees and benefits

In order to obtain an exemption from tuition fees or to request other additional benefits (scholarships, accommodation in a university residence, food services or other benefits), international students residing abroad and requesting a visa need to submit an online application by the end of August 2025. Online applications need to be submitted on the website <a href="https://www.er-go.it">www.er-go.it</a> before enrolment.

Students need to have the documents translated and legally certified, stating their financial situation. The Call for Benefit Applications will be published approximately at the beginning of **July 2025**. Students are invited to check the various deadlines.
