ARTICLE 1 – Establishment

Pursuant to Ministerial Decree No. 270 of 22/10/2004, the University of Modena and Reggio Emilia activates the Postgraduate Course “*Sound Engineering*”, for the academic year 2025/2026.

<p>Professional profile the course intends to provide:</p> <p>The course aims to provide theoretical and practical knowledge in the field of the technology of sound engineering, with reference to the state of the art in the sector.</p>

Educational objectives:

The objective of the course is to provide fundamental theoretical knowledge for the comprehension, analysis and design of modern sound diffusion systems.

Such knowledge ranges from the fundamental principles of acoustics, to transducers and speakers, electronic amplifying systems and digital sound filtering, and also soundproofing systems.

Attività formative:

The teaching is organized into the four didactic modules described below, which include both theoretical lessons (the greater part of the course) and practical experience:

1) Acoustics

Introduction to acoustics: the nature of the sound, its generation, quantity, propagation, punctiform sources and cylindrical sources;

Psychoacoustics: sound levels and perception of sound, spectral composition, normal audiogram and weighting curves.

Acoustics of internal environment: reflection, transmission and absorption, temporal evolution of sound, reverberation, reverberation field and time (RT)

Acoustic of open spaces: effects of temperature, humidity and wind, diffraction, masking, acoustic air absorption.

2) Electroacoustics

Transducers: typology, static and dynamic characteristics; model for designing (Thiele-Small) and for the simulation of electro-mechanical properties; compression drivers and horn loading.

Loudspeaker system: typology, operation, materials and technology; concepts of bands and cross-overs, types of cabinet, directivity (dispersion curve) and characteristics of radiation

3) Electronics

Introductory concepts: electronic technology and devices (MOSFET, IGBT, SiC diode); signal amplifiers: topologies, efficiency, distortion, matching, feedback, stability and compensation.

D class Power amplifiers: topology, losses, modulation strategy and indexes of performance.

Digital signal processing: DSP: general characteristics, operation, processing and standby time basic and planning algorithms; digital filters (FIR-IIR); special filters for audio applications;

4) Sound systems

Speakers: audio chain, the speaker and amplifier system (audio processor and control)

Sound reinforcement system: multiband mixers; subwoofers, line arrays, digital steering arrays. Simulation software, models of mixers; radiation balloons

Design of sound reinforcement system: choice of mixers and their insertion based on the requirements of power and directivity; dimensioning and installation; design of a sound system using acoustic simulation.

Individual and group exercises in the laboratory.

Duration and organization of the course:

Online lessons will be available starting from April 22, 2026. Lessons and practical experiences will be delivered approximately 75% online, in collaboration with the University's E-learning Center. The remaining 25% of lessons and exercises will be conducted in the traditional format and will be concentrated in the week of September 14 to 17, 2026.

In-person lessons will take place at the RCF Academy location, Via Giovanni Bovio 2/1, Reggio Emilia (RE), and at the Department of Science and Engineering Methods. The course will conclude on September 18, 2026, with a final exam consisting of a written test on the technical content covered throughout the course.

Language: English

Enrolment fee: one instalment of € 850,00 payable upon enrolment.

Total hours: 375 hours (of which 120 hours are lectures and alternative teaching and 255 are individual study).

CFU (University Credits): 15

Teaching staff: The teaching staff consists of members of the University of Modena and Reggio Emilia, University of Parma and well-reputed experts in sector.

Method of selection: by qualifications.

ARTICLE 2 – Admission Requirements

The admission procedure is open to all individuals, without age or citizenship restrictions, who, by the deadline of the call, hold the required access qualification as specified in Article 1 of this call, or an equivalent academic qualification obtained abroad.

For candidates holding a foreign qualification, please refer to the procedure outlined in Article 3 "Admission Applications." For further information, consult the website www.miur.it – Universities – Students – Foreign Students. Candidates from non-EU countries who require a visa are reminded of the obligation to submit a pre-enrollment application at <https://www.universitaly.it>.

The information provided by candidates will be subject to thorough verification by the relevant offices to ensure its accuracy.

Candidates are admitted to the selection procedure subject to verification of the required qualifications.

ARTICLE 3 – Admission Applications

Admission applications to the selection procedure and any other relevant attachments (titles and documents deemed useful for the selection process) must be submitted to this Administration, under penalty of exclusion, by the strict deadline indicated in Article 1, exclusively via the following online procedure:

- ◆ **Go and register on the website www.esse3.unimore.it**, a page which can also be accessed by following the path <http://www.unimore.it> – Services – IT Services – the ESSE3 portal, and then log in with the credentials received after registration or using your own SPID credentials (Public Digital Identity System). Once logged in, go to the "Student Area", and follow "Admission" – "Enrollment".

All titles and documents deemed useful for the selection procedure must be attached exclusively in electronic format .pdf or .rtf, with a maximum size of 20 MB. Attachments larger than 20 MB must be split into multiple parts.

For the admission application, a contribution of €41.00 (which includes €25.00 for administrative services and €16.00 for stamp duty) is required and is non-refundable.

After filling out the application, access www.esse3.unimore.it: once logged in, go to the "Taxes" section to view the amounts due and make the payment via the pagoPA circuit. Payment methods are indicated on the University's website at the following link: <https://www.unimore.it/it/didattica/immatricolazioni-e-iscrizioni/pagamenti>.

The payment of €41.00 must be made by the strict deadline indicated in Article 1.

Please note that the University will rely on the payment date shown on the electronic payment receipt (RT). Payments made after the stated deadline will not be considered valid for ranking purposes.

Attention! According to "AgID" (Agency for Digital Italy) guidelines, the payment operation may be processed

by the Payment Service Provider (PSP) on the day following the payment request, preventing the inclusion in the ranking.

The application will only be considered correctly submitted when the data has been saved ("Save Data") after the applicant has explicitly confirmed the validity of the application at the end of the online procedure (refer to the "Admission Application Guide" published on the University website at <https://www.unimore.it/it/didattica/corsi-di-perfezionamento>).

Before saving the data ("Save Data") after the "explicit confirmation of validity of the application," but always before the application deadline, candidates may add, modify, or delete titles and documents by accessing the webpage above (it is recommended to consult the "Admission Application Guide" in such cases).

The submission of the application and related attachments via email or fax is not permitted.

Applications submitted in accordance with the above procedure will be considered timely only if received by this Administration before the strict deadline of the call. Applications submitted after this deadline or in ways other than those described above will be excluded.

During the online application procedure, the candidate must declare, under their responsibility:

- ◆ full name and surname;
- ◆ place and date of birth;
- ◆ residence, phone/cell phone, address for potential selection tests, and email contact;
- ◆ tax code (for those already in possession of it; those without a tax code must confirm the one automatically generated by the system);
- ◆ citizenship;
- ◆ possession of the required qualification for access to the course (Article 1 "Admission Requirements" of the call) or an equivalent academic qualification obtained at foreign universities;
- ◆ exact name of the Course the candidate intends to apply for;
- ◆ curriculum vitae;
- ◆ titles and other documents;
- ◆ in the case of candidates with disabilities, according to Law No. 104 of February 5, 1992, the type of assistance needed for exam participation.

By submitting the application, the candidate agrees to promptly notify any changes to their residence or contact details.

Exclusion of candidates may be communicated at any time, ex officio, for failure to meet the admission requirements.

The Administration assumes no responsibility in case of loss of communications due to incorrect information provided or failure or delay in updating contact details, as well as for technical issues or third-party faults, accidents, or force majeure. Furthermore, the Administration is not responsible for the failure to receive documents due to third-party issues or errors in the attachment submission by the candidate, or any network downtime.



TITLES and DOCUMENTS:

The attachments to be submitted with the admission application differ depending on whether the candidate holds an Italian or foreign qualification.

Candidates with an Italian qualification:

- ◆ self-certification of possession of the access requirement under Articles 46 and 47 of D.P.R. 445/2000, using the form in Annex A (at the end of the call);
- ◆ titles and documents deemed useful for evaluation and their list;
- ◆ curriculum vitae;
- ◆ a copy of a valid ID;
- ◆ a copy of the residence permit or receipt of the renewal request (for non-EU foreign students who are already residing).

Candidates with a foreign qualification:

- ◆ certificate of the qualification with a list of exams taken, with translation into Italian (or possibly using the form in Annex B); for those who only hold a five-year secondary education diploma, attach only the qualification with translation into Italian (or possibly using the form in Annex B);
- ◆ titles and documents deemed useful for evaluation and their list;
- ◆ curriculum vitae;
- ◆ a copy of a valid ID/passport;
- ◆ a copy of the residence permit (only for non-EU residents).

Candidates with foreign qualifications are admitted to the selection procedure subject to verification of the above requirements. **In any case**, enrollment will only be finalized upon submission, within the enrollment deadlines, of all necessary original documents to the Master's and Higher Education Office, located at Via Università 4 – Modena (**listed in the relevant section of Article 5**). It is recommended to collect all necessary documentation well in advance.

Pursuant to Article 15 of Law No. 183 of November 12, 2011, it is specified that certificates issued by public authorities concerning personal status, qualities, and facts are valid and usable only in relationships between private individuals. In relations with public administration bodies and public service providers, certificates and deeds of notoriety are always replaced by declarations under Articles 46 and 47.

The information transmitted by the candidates will be thoroughly checked by the competent offices to verify its accuracy.

ARTICLE 4 – Admission Procedures and Publication of the Ranking

The selection procedure and any potential schedule for the tests are outlined in Article 1.

At the end of the selection procedure, the committee will prepare the final merit ranking. Candidates will be admitted to the Course, with a decision by the Rector, once the regularity of the documents has been verified, according to the order of the ranking and up to the number of places available for the Course.

These publications will, for all legal purposes, serve as official notification to the interested parties. NO TELEPHONIC INQUIRIES WILL BE PROVIDED.

ARTICLE 5 – Enrollment of Admitted Candidates

During the enrollment procedure, the system will require the following documents:

- ♦ **Digital copy** (front/back) **of the identity document** (Identity Card, Driver's License, or Passport).
- ♦ **Passport-sized photo** (note: please ensure the photo is already in the correct format and orientation, 3.5 x 4.0 cm, with a neutral background and the face in a frontal view, as the image cannot be adjusted in the system).

Under penalty of exclusion, candidates who are successfully placed in the final merit ranking must enroll in the Course **within twelve consecutive calendar days**, starting from the day after the opening of enrollment, exclusively through the following online procedure:

- ♦ **Go to the University's website at** www.esse3.unimore.it and log in using the username and password assigned by the system upon registration for the admission test, or your existing credentials if you are a student at the University of Modena and Reggio Emilia, or use your SPID (Public Digital Identity System) credentials. Then, follow the path in the Student Area: "Enrollment" – "Enrollment in courses with restricted access." The "Online Enrollment Guide" can be consulted at the following link: <https://www.unimore.it/it/servizi/guide-alle-procedure-line>.

Candidates successfully placed in the final merit ranking must confirm the data already entered during the application submission and finalize the enrollment procedure to generate the enrollment application in PDF format. It is not necessary to send the generated PDF at the end of the procedure.

After completing the enrollment application, access www.esse3.unimore.it: once logged in, go to the "Taxes" section to view the amounts due for the required contributions. Payment must be made, under penalty of exclusion, by the deadline mentioned above.

IMPORTANT: the University will rely on the PAYMENT date shown on the electronic payment receipt (RT).

Attention: The payment operation may be processed the day after the request was made by the payer, potentially preventing enrollment.

The payment of the fee must be made by the deadline specified in Article 1 – "Enrollment Contributions" of this call, exclusively via the methods mentioned above.

Closing the enrollment application on Esse3 without having made the required payment will not complete the enrollment process. The generated PDF does not need to be sent after the procedure.

For EU and non-EU candidates residing in Italy, holding a foreign qualification:

They must submit, by the final deadline for enrollment, the following **original documents** to the Master's and Higher Education Office, located at Via Università, 4 – Modena:

1. Original (or certified copy) of the DEGREE CERTIFICATE, translated and legalized by the Italian Embassy/Consulate in the country where the qualification was obtained, or in the country where the issuing school is located;
2. DECLARATION OF VALUE of the degree certificate, issued by the Italian Embassy/Consulate in the country where the qualification was obtained, or in the country where the issuing school is located

A DECLARATION issued by ENIC-NARIC centers confirming the level and years of schooling for the qualification

Alternatively:

DOCUMENTATION related to the degree certificate issued by CIMEA – www.cimea.it, specifically:

- a. **CERTIFICATE OF CORRESPONDENCE** downloadable directly from the "Ardi" platform at <https://ardi.cimea.it/it> (for countries that are signatories of the Lisbon Convention), or if the country where the qualification was obtained is not listed, a **CERTIFICATE OF COMPARABILITY**, to be requested from CIMEA via registration at <https://cimea.diplo-me.eu>.
- Attention: CIMEA will not issue a Certificate of Comparability if a Certificate of Correspondence is available.
- b. **VERIFICATION CERTIFICATE** to be requested from CIMEA through registration on <https://cimea.diplo-me.eu>. More information can be found on <https://www.cimea.it/pagina-attestatati-di-comparabilita-e-verifica-dei-titoli>;
3. Certificate with the list of exams taken during the study program (transcript of records) or Diploma Supplement (if adopted); not required for those holding only the five-year secondary education diploma;
 4. Residence permit or receipt, issued by the post office in Italy, proving the submission of a residence permit renewal request (for non-EU students residing in Italy);
 5. Identity Document or Passport;
 6. Passport-sized photo.

Certificates issued by the relevant authorities of the country of citizenship must comply with the regulations in force in that country and must also be translated and legalized by the relevant Italian consular authorities. Documents in foreign languages must be accompanied by a certified Italian translation, made by the relevant Italian diplomatic or consular representative or by an official translator.

The Office, after verifying the correctness and completeness of the documentation submitted by the student, will make the required contributions for enrollment available in Esse3 under the "Taxes" section, to be paid through the pagoPA circuit, and finalize the enrollment once payment is received.

Foreign students who do not yet have a tax code must request it from the Agenzia delle Entrate (once in Italy) and submit a copy of the tax code card issued by the Agenzia, within 30 days from the start of the Course, to the Master's and Higher Education Office, exclusively via email to master_altaformazione@unimore.it.

Those who fail to regularize their enrollment within the terms and procedures outlined above will be considered as having forfeited their place.

Candidates who have provided false declarations will be disqualified. Vacant places will be assigned to other candidates according to the order of the final merit ranking (Article 6).



If the minimum number of enrolled students is not reached, the course activation will be revoked, and any fees paid will be refunded.

In the event of enrollment and subsequent withdrawal from the course, the candidate must notify the Rector by e-mail, copying the Director of the Course in. If the withdrawal occurs at a time when the ranking of eligible candidates can still be used to fill the vacant place, the University reserves the right to refund the fees paid at the time of enrollment. If the withdrawal occurs at a later time, the fees will not be refunded.

ARTICLE 6 – Substitution

In case of vacant places, those entitled to a spot will be required, via email, to enroll under penalty of forfeiture, following the procedures outlined in the previous article, **within a strict deadline of four consecutive calendar days**, starting from the day after the email is sent.

The University of Modena and Reggio Emilia disclaims any responsibility in the case of incorrect addresses provided by the candidate or failure to promptly notify any address changes via email to master_altaformazione@unimore.it.

ARTICLE 7 – Attendance Requirements

Attendance at classes is mandatory, and the minimum requirements for the issuance of the certificate are:

- ♦ Attendance for at least 75% of the total duration of the theoretical classes;
- ♦ Passing the final exam.

ARTICLE 8 - Academic Credits and Degree Awarded

The Postgraduate Course referred to in Article 1 grants 15 university credits (CFU) as provided in Article 2, paragraph 5, of the “Regolamento per la disciplina dei Master universitari e dei Corsi di Perfezionamento, di aggiornamento professionale e di preparazione agli esami di stato per l’abilitazione all’esercizio delle professioni ed ai concorsi pubblici”.

At the end of the course, upon passing the final exam, a certificate of attendance will be issued along with the allocation of university academic credits (CFU).

The issuance of the certificate is contingent upon being up to date with the payment of fees, contributions, and any additional charges.

ARTICLE 9 - Processing of Personal Data

The University Administration, in accordance with current regulations, commits to using the personal data provided by the candidate for the purposes of the selection process and for institutional purposes.

Participation in the selection process implies, in compliance with current regulations, tacit consent for the publication of the candidate's personal data and the data related to the admission tests on the University of Modena and Reggio Emilia website.
